6. Diversity Council Memo on Chancellor Search

- -The memo asks that that the selection of the search committee be representative of that of the state and our institution.

- -Motion was made and approved to draft a memo to BOR stating the interest/desire for the EC to serve and nominate a member of our choosing. Contingent upon electronic approval of the EC. Include that the EC is representative of a diverse university staff.
- -Suggested that for the future we put in the bylaws that the sitting Chair or Chair-Elect always be the person that represent the EC on all search committees, should their schedule allow.

7. Follow-up: Employees Receiving Degrees
